Enclosed please find two hard copies with electronic files of the Periodic Monitoring Report for Vapor-Sampling Activities at Material Disposal Area H, Solid Waste Management Unit 54-004, at Technical Area 54, Fourth Quarter Fiscal Year 2009.

The analytical results continue to confirm the presence of volatile organic compounds (VOCs) and tritium in pore-vapor samples and are consistent with previous sampling results. All VOCs detected during the fourth quarter of fiscal year 2009, as well as the previous three quarters, were less than the concentrations needed to exceed groundwater screening levels, and tritium activity decreased with distance from Material Disposal Area H.
