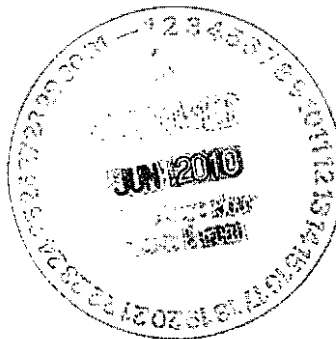

Enclosed please find two hard copies with electronic files of the Investigation Report for Upper Sandia Canyon Aggregate Area. This report presents the results of site-characterization activities conducted during a 2009 investigation as directed by the approved investigation work plan for Upper Sandia Canyon Aggregate Area. The sites investigated are located at Technical Area 03 (TA-03), TA-60, and TA-61 and consist of current and former industrial waste lines, drainlines and outfalls, former transformer pads, storage areas, a former asphalt batch plant, a former wastewater treatment plant, a septic system, surface disposal areas, and areas of suspected soil contamination. The 2009 investigation activities included collecting soil, sediment, rock, and swipe samples, and the excavation and removal of a former septic tank.
