Enclosed please find two hard copies with electronic files of the Investigation Report for Upper Cañada del Buey Aggregate Area. This report presents the results of site characterization activities conducted during a 2010 investigation, as directed by the approved investigation work plan for Upper Cañada del Buey Aggregate Area. The sites investigated are located at Technical Area 46 (TA-46) and former TA-04 (now within TA-52) and consist of current and former drainlines and outfalls, storage areas, storage sheds, surface impoundments, inactive septic systems, inactive dry wells, surface disposal areas, and areas of suspected soil contamination. The 2010 investigation activities included collecting soil, sediment, and rock samples and excavating and removing four former septic tanks.
