Subject: Submittal of the Work Plan for Well R-61

Dear Mr. Bearzi:

This Work Plan for Well R-61 follows a proposed schedule described in our July 10, 2010, Phase II Investigation Work Plan for Sandia Canyon submittal. The Phase II Work Plan addresses the New Mexico Environment Department's (NMED's) concerns in its February 9, 2010, letter, "Approval with Modification Investigation Report for Sandia Canyon, Los Alamos National Laboratory."

Regional aquifer well R-61 will be located on the mesa south of Mortandad Canyon, about 1850 ft west of well R-50 and 2000 ft southeast of well R-15 (Figure 1 in the R-61 work plan). Well R-61 is being installed to reduce uncertainty about the nature and extent of chromium contamination in the area south of wells R-42 and R-28 near the Laboratory boundary with San Ildefonso Pueblo.
