Dear Mr. Bearzi:

Enclosed please find two hard copies with electronic files of the work plans to plug and abandon wells and boreholes identified in the New Mexico Environment Department's (NMED's) letter dated July 30, 2010.

The NMED correspondence lists an order of priority for wells and boreholes from 1 to 21 for 30 wells and boreholes. Los Alamos National Laboratory (the Laboratory) proposes to plug and abandon 30 wells over a 3-yr period, with the first 10 priority wells or boreholes to be completed in fiscal year (FY) 2011, the second 10 in FY2012, and the last 10 in FY2013. The attached work plans are based on preliminary research of these legacy wells and boreholes. As the Laboratory completes field investigations at these locations, relevant information may impact the scope of the abandonment efforts. NMED will be notified of any changes to the procedures to plug and abandon the wells and boreholes.
