Enclosed please find two hard copies with electronic files of the Phase II Investigation Work Plan for North Ancho Canyon Aggregate Area.

This Phase II investigation work plan includes several proposed actions in addition to what is recommended in the approved investigation report for North Ancho Aggregate Area, revision 1. Specifically, this Phase II investigation work plan recommends

- the delay of previously proposed investigations at solid waste management unit (SWMU) 39-002(a) because of changed conditions,
- abandonment of 5 shallow wells and 12 angled boreholes at SWMUs 39-001(a) and 39-001(b), and
- final removal of remaining contaminated media at SWMUs 39-001(a) and 39-001(b).
