Please be advised that Los Alamos National Laboratory (the Laboratory) does not intend to submit the drilling work plans discussed in NMED's General Comment 4 in its NOD. As discussed in our response, it is the Laboratory's position that the installation of a new intermediate and regional well in this part of Laboratory property is premature. The need for new wells will be assessed using the results from the investigation proposed in the work plan.
