Dear Mr. Bearzi:

Enclosed please find two hard copies with electronic files of the response to the notice of disapproval for the Phase II Investigation Work Plan for North Ancho Canyon Aggregate and Revision 1 of the plan. Also enclosed is an electronic copy of a redline strikeout version of the report that includes all changes made in response to the New Mexico Environment Department's (NMED's) notice of disapproval, dated March 4, 2011. A table detailing where revisions have been made to the plan with cross-references to NMED's numbered comments is also included.

Los Alamos National Security (LANS) and the U.S. Department of Energy (DOE) note that the majority of NMED's comments were related to multi-increment (MI) sampling that was performed as part of waste management activities at Solid Waste Management Units (SWMUs) 39-001(a) and 39-001(b). The investigation work plan has been revised to provide additional details concerning this sampling. Although LANS and DOE acknowledge that NMED does not agree with the MI sampling approach, data from the MI sampling are not being used for final decisions concerning cleanup of these sites. Rather, these data will be used to guide additional waste removal activities for these two sites. Final sampling to confirm removal of residual contamination above cleanup levels will be performed using the discrete sampling approach directed by NMED.
