# Dave,

The purpose of this e-mail is to inform you of sampling to be conducted at the General's Tanks, which are located at within MDA A at Technical Area 21. On March 22, 2011, the Laboratory will attempt to collect samples of liquid, sludge, and dried sludge from each of the two tanks. These samples are being collected to characterize the inventory of radionuclides within the tanks. Due to the expected levels of radioactivity in these samples, they will be submitted for analysis at an on-site analytical laboratory. This sampling is not being conducted in accordance with Consent Order investigation activities for MDA A, but the resultant data may be used to support decisions regarding the disposition of the tanks' radionuclide content, which will facilitate the later disposition of the emptied tanks.
