The New Mexico Environment Department (NMED) has received your March 24, 2011 letter (Letter) regarding the assessment of fees, pursuant to 20.4.2.203.A(6) NMAC, for the Los Alamos National Laboratory Hazardous Waste Facility Permit public hearing. NMED has reconsidered its assessment and removed from the costs for outside counsel and expert witness on the attached revised assessment.

The assessment for ASTM International was for the purchase of ASTM publications to supplement the administrative record in preparation to support several issues raised during the public comment period on the draft permit and at the public hearing concerning site assessment, monitoring well, groundwater and sampling practices. NMED believes the assessment of these fees is appropriate under 20.4.2.203.A(2) NMAC.

NMED hereby withdraws the February 22, 2011 Invoice # HWB-LANL-2010-HF, and issues in lieu thereof the attached invoice.

In addition, NMED has invoiced the Permittees for a number of other submittals since the February 22, 2011 hearing fee assessment as shown in the Supplemental Fee Agreement Invoice Summary FY11 (attached).
