Dear Messrs. Smith and Cantwell:

The New Mexico Environment Department (Department) received a request from the U.S. Department of Energy, National Nuclear Security Administration (Permittee), dated March 16, 2011 to modify the Los Alamos National Laboratory (LANL) Hazardous Waste Permit (Permit). The modification requests eleven changes to revise the emergency equipment lists, clarify Permit conditions and inspection activities, add and remove structures from permitted units, and revise figures and text associated with these clarifications, additions, and removals.

The Department has reviewed the request and concurs that these changes are Class 1 modifications or Class 1 modifications requiring prior approval by the Department in accordance with 20.4.1.900 NMAC, incorporating 40 CFR §§ 270.42(a)(2) and (d). The Department has further determined that the Permittee has noticed this Permit modification in accordance with 20.4.1.900 NMAC, incorporating 40 CFR §§ 270.42(a)(1)(i) and (ii). The Department hereby

approves the Class 1 permit modifications requiring prior approval. The modifications are to be put into effect as requested by the Permittee in accordance with 20.4.1.900 NMAC, incorporating 40 CFR § 270.42(a).

The New Mexico Hazardous Waste Permit and Corrective Action Fee regulations, Section 20.4.2.201.F, require the assessment of a fee to modify a permit. A fee invoice is attached and that fee must be paid in accordance with 20.4.2.301 NMAC. If you disagree with the fee assessed you may notify the Department in writing at the address above of your intent to appeal the invoice under the provisions of 20.4.2.302 NMAC.




