## Subject: Submittal of the Response to the Notice of Disapproval for the Investigation Report for Ancho, Chaquehui, and Indio Canyons and Revision 1

Dear Mr. Kieling:

Enclosed please find two hard copies with electronic files of the Response to the Notice of Disapproval for the Investigation Report for Ancho, Chaquehui, and Indio Canyons and Revision 1 of the report. Also enclosed is an electronic copy of a redline-strikeout version of the report that includes all changes made in response to the New Mexico Environment Department's (NMED's) notice of disapproval (NOD), dated April 1, 2011. A table detailing where revisions have been made to the report with cross-references to NMED's numbered comments is also included.

Comment number 2 of the NOD specified either amending the report to include analytical data on dioxins and furans in canyons sediment or proposing collection and analysis of such samples in a separate work plan. As agreed to in a meeting with NMED staff on May 26, 2011, Los Alamos National Laboratory (the Laboratory) will prepare a separate work plan to address potential dioxin and furan contamination in sediment investigation reaches in all of the south canyons (Ancho, Chaquehui, Indio, Potrillo, Fence, and Water Canyons and Cañon de Valle) below potential Laboratory sources for these constituents. This work plan will be submitted by February 15, 2012, which is the date specified in an April 14, 2011, letter from NMED for submission of a work plan to evaluate dioxins and furans in Potrillo and Fence Canyons.
