Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Buildings or Fixed Structures Scheduled to be Demolished 4th Quarter Calendar Year 2011*, dated September 14, 2011 and referenced by ENV-RCRA-11-0189/LAUR 11-05066.

The investigations are not complete at several Solid Waste Management Units (SWMUs) located within 50 ft. of the buildings proposed for demolition. The discussion provided for SWMUs and Areas of Concern (AOCs) located within 50 ft of the footprint for structure 18-0030 provided in the table on page 3 is incomplete. Several of these SWMUs are, or would be proposed for further investigation. Some of the proposed sampling locations are adjacent to the buildings scheduled for demolition. The demolition activities must be documented to ensure that there are no adverse impacts to SWMUs where investigations are not complete.

Pursuant to Section 1.17.3 of the Los Alamos National Laboratory Hazardous Waste Permit (Permit), NMED hereby requires notice of demolition 30 days prior to the commencement of demolition activities, for the following structures:

- 15-0456, Transportable Wood Lt. Frame
- 18-0028, Steel Braced Frame
- 18-0030, Concrete Sheer Walls
- 18-0031, Concrete Sheer Walls

- 18-0189, Cast Concrete
- 22-0001, Metal and Wood Framed Structures
- 35-0224, Trailer-Wood Lt. Frame
- 35-0226, Trailer-Wood Lt. Frame
- 35-0227, Trailer-Wood Lt. Frame

The Permittees must provide a copy of the demolition reports, if prepared, to NMED within 30 days after the reports are completed in accordance with Section 1.17.3 of the Permit.
