Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Request for Extension to Complete Perched Intermediate Well R-10i* (Completion) dated November 10, 2011 and referenced by EP2011-0386.

The Permittees request the extension to complete well R-10i due to the need to focus on removal of transuranic (TRU) waste from Technical Area (TA) 54 to the Waste Isolation Pilot Plant, located in Eddy County, New Mexico. The need to remove TRU waste stored at TA-54 is aligned with Governor Martinez' policy to prioritize groundwater and surface water protection and accelerate the removal of TRU waste stored at Los Alamos National Laboratory.



The Permittees stated cause for the requested time extension is acceptable. The submittal date for the Completion is hereby postponed from January 20, 2012 to **January 20, 2014**, as requested. NMED may re-evaluate the need for this extension based on the Permittees' progress in accelerating the removal of TRU waste from TA-54 or if new information is discovered related to groundwater contamination in the vicinity of Regional Well R-10. The Permittees must notify NMED, within 30 days of receipt of such information, should funds become available in the future that allow for the installation of Well R-10i to be completed prior to January 20, 2014.

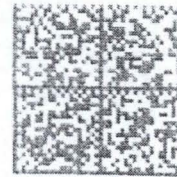
