Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Request for Extension to Submit the Phase II Investigation for Sandia Canyon* (Report) dated December 2, 2011 and referenced by EP2011-0406.

The Permittees request the extension to submit the Report from April 30, 2012 to September 30, 2012 due to the need to obtain groundwater data from newly installed monitoring wells R-61 and R-62 to include in the investigation. NMED understands that both well R-61 and R-62 are affected by impacts from drilling and well construction and therefore data acquired from the wells may not be representative of aquifer conditions. Both wells must be assessed for their ability to produce representative samples and further well development or replacement may be necessary for one or both wells.

Assessment of the wells and any actions to rehabilitate them will likely not be completed during this federal fiscal year. The Permittees state in the extension request that quarterly sampling of well R-61 has been ongoing since May 2011 and that the data from the second sampling of well R-62 will be available by June 2012. Based on the history of well R-62, the sampling data from this well may not be representative and any conclusions derived from the data obtained from this well may be unreliable. Because any data collected in the near future may not be representative due to the identified problems with well construction, any data quality issues must be discussed in the Report.

Since it is anticipated that the data acquired from the second quarter sampling of newly installed well R-62 will be available by June 2012, the Permittees have shown good cause for an extension that will allow for the inclusion of the second round of groundwater monitoring data from well R-62. NMED hereby approves a time extension to submit the Phase II Investigation Report for Sandia Canyon from April 30, 2012 to **July 31, 2012**.
