Subject: NPDES Permit No. NM0030759 – Submittal of Certification of Installation of Enhanced Control Measures for Eight Site Monitoring Areas

Dear Ms. Johnsey:

These documents are being submitted in accordance with the requirements of the National Pollutant Discharge Elimination System (NPDES) Permit No. NM0030759 for Los Alamos National Laboratory, issued to Los Alamos National Security, LLC, and the U.S. Department of Energy, effective November 1, 2010. As specified in Part I, Section E.1. (c), "Permittees shall certify completion of installation of control measures under this subsection to EPA within 30 days of completion of all such measures at the Site...."

Accordingly, the certification documentation for enhanced control measures completed at eight Site Monitoring Areas (SMAs) within the last 30 days is enclosed. The documentation is organized into SMA-specific reports (Table 1). Each report includes a signed certification statement, a list of the enhanced control measures installed at the SMA, a photograph of each enhanced control measure, and a site map.
