These documents are being submitted in accordance with the requirements of the National Pollutant Discharge Elimination System (NPDES) Permit No. NM0030759 for Los Alamos National Laboratory, issued to Los Alamos National Security, LLC, and the U.S. Department of Energy, effective November 1, 2010. Completion of corrective action is being certified to the U.S. Environmental Protection Agency (EPA) as specified in Part I, Section E.2. (d),

The Site has achieved RCRA "corrective action complete without controls/corrective action complete with controls" status or a Certificate of Completion under NMED's Consent Order....

This certification that corrective action is complete was prepared in accordance with 40 Code of Federal Regulations 122.22(b).
