These documents are being submitted in accordance with the requirements of the National Pollutant Discharge Elimination System (NPDES) Permit No. NM0030759 (for Los Alamos National Laboratory, issued to Los Alamos National Security, LLC, and the U.S. Department of Energy, effective November 1, 2010. Completion of corrective action is being certified to the U.S. Environmental Protection Agency as specified in Part I, Section E.2(c):

The Site has achieved a no exposure condition as completion of corrective action of Site 54-017 at site monitoring area (SMA) PJ-SMA-20 under Part 1.E.2(c) of the Individual Permit (IP).

The certification that corrective action is complete was prepared in accordance with 40 Code of Federal Regulations 122.22(b). Accordingly, the documentation for no exposure measures at PJ-SMA-20, Site 54-017, is enclosed. As required in Part I, Section E.1(b), the documentation includes a signed certification statement with a description of a no exposure condition with as-built drawings. Additionally, the Permittees will collect one sample and make the analytical results available via e-mail notification and on the public website pursuant to Section I.7 of the IP.
