Dear Messrs Maggiore and Graham:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Second Request for an Extension to Submit the R-62 Well Completion Report* (Request) dated March 26, 2012 and referenced by EP2012-0083.

The Permittees request a second extension to submit the required well completion report for regional aquifer well R-62 from the current due date of March 30, 2012 to April 20, 2012. The time extension is necessary because of equipment problems and delays at the on-site analytical laboratory with respect to the analyses of samples collected from well R-62 during well development. The extension will allow for the inclusion of the analytical results from well development in the completion report. NMED considers this to be good cause for the extension.
