Dear Messrs Maggiore and Mousseau:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Drilling Work Plan for Well R-63i* (Plan) dated February 2013 and referenced by EP2013-0015. The Plan was received on February 14, 2013. NMED has reviewed the Permittees' Plan and hereby issues this approval with the following modification.

During borehole advancement, the downward migration of contaminated (e.g., RDX) groundwater from the upper-deep perched zone to the lower targeted perched zone must be prevented. Therefore, upon reaching the upper-deep perched zone, the Permittees must seal off that zone and remove all accumulated perched zone groundwater from the borehole before continuing to advance the boring into the lower-deep perched zone. The seal must extend at minimum of 20 feet below the base of the upper-deep perched saturated zone.

In accordance with Section IV.3.A.e.iv of the March 1, 2005 Compliance Order on Consent (revised October 29, 2012), the Permittees must: a) submit a well completion summary fact sheet within 30 days of R-63i completion; b) develop the well within 30 days of completion; and c) submit the R-63i well completion report within 150 days of well completion.

Based on the Permittees' proposed schedule to complete R-63i by September 30, 2013, the summary fact sheet must be submitted no later than **October 30, 2013**, the well must be developed no later than **October 30, 2013**, and the well completion report must be submitted no later than **February 27, 2014**.
