Dear Messrs. Maggiore and Mousseau:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Request for Extension to Submit the Phase II Investigation Report for Upper Los Alamos Canyon Aggregate Area*, dated January 27, 2014 and referenced by EP2014-0036.

The Permittees request the extension to submit the Phase II Investigation Report for Upper Los Alamos Canyon Aggregate Area (IR) due to the need to focus efforts on shipment of aboveground transuranic (TRU) waste from Technical Area (TA) 54 to the Waste Isolation Pilot Plant.

This is the third extension request for the submittal of this IR. The Permittees' first extension request changed the submission date for the IR from August 30, 2012 to August 30, 2013. The second request moved the extension date from August 30, 2013 to February 28, 2014. This third extension changes the submission date from February 28, 2014 to **June 30, 2014**, as requested.

NMED is concerned over delays that affect the progress of corrective action; however, NMED understands the ongoing issues related to the allocation of DOE resources to Los Alamos National Security, L.L.C., to fund corrective action at the laboratory. The Permittees must notify NMED, within seven days of receipt of such information, should funds become available in the future that allow for the IR to be submitted prior to June 30, 2014. If funding becomes available, NMED may re-evaluate the deadline for completion of this project.
