The New Mexico Environment Department (NMED) received notice from the U.S. Department of Energy National Nuclear Security Administration and the Los Alamos National Security LLC, (collectively the Permittees) dated February 27, 2014 of a Class 1 Permit Modification to Update Figures in the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit (Permit).

NMED has review the permit modification request and concurs that these changes are Class 1 modification in accordance with 20.4.1.900 NMAC, incorporating 40 CFR 270.42(a). 
