The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Request for Extension to Submit the Investigation Work Plan for South Ancho Canyon Aggregate Area (IWP)* dated June 09, 2014 and referenced by EP2014-0233.

The Permittees are requesting a third extension to submit the IWP for South Ancho Canyon Aggregate Area. The first extension moved the submission date to September 30, 2013, and the second extension moved the submission date to June 30, 2014.
