Enclosed please find two hard copies with electronic files of the periodic monitoring reports for White Rock, TA-21, TA-54, and TA-16 260.

Analytical results for samples collected on the Pueblo de San Ildefonso have been excluded from the subject periodic monitoring reports (PMRs). The Protocol for Protecting Confidential Pueblo Information included in the Memorandum of Agreement between the U.S. Department of Energy (DOE)/National Nuclear Security Administration (NNSA) and the Pueblo de San Ildefonso requires that DOE/NNSA not release data the Pueblo deems confidential to the general public or any other governmental agency without providing a 60-day period for the Pueblo to review the data.

A separate PMR providing analytical results from samples collected at locations on the Pueblo has been prepared for the Pueblo's review and will be submitted to the New Mexico Environment Department at a later date, following their release by the Pueblo.
