Dear Ms. Gelles and Mr. Brandt:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Drilling Work Plan for Replacement Perched Aquifer Well R-55ir* (Plan) dated March 11, 2015, referenced by EP2015-0040, and received on March 11, 2015.

NMED has reviewed the Plan, and hereby issues this Approval with the following modification.

The Permittees propose to drill the replacement well R-55ir approximately 50 feet away from the impacted well R-55i. However, NMED is concerned that 50 feet may not be an adequate distance to avoid capturing impacted groundwater present at R-55i. Therefore,

the Permittees must drill R-55ir at least 300 feet upgradient or near upgradient from well R-55i. If such location is not attainable due to surface archeology, topography, or other factors, the Permittees must discuss the proposed location of R-55ir with NMED before commencing drilling.

Well R-55ir must be completed no later than **September 30**, 2016, as proposed in the Plan. The Permittees must submit the Fact Sheet for the well no later than **October 30**, 2016, and the Well Completion Report no later than February 27, 2017.
