The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Request to Defer Submittal of the Phase II Investigation Report for Threemile Canyon Aggregate Area* (Request), dated August 13, 2015 and referenced by ADESH-15-117.


The Permittees request to defer submittal of the Phase II Investigation Report for Threemile Canyon Aggregate Area (IR) until the Supplemental Investigation Report (SIR) for Threemile Canyon Aggregate Area has been submitted in February 2016. NMED approved an earlier extension request on June 22, 2012 that extended the submission date for the IR from August 31, 2013 to August 31, 2015.

The Permittees state that the SIR will include recommendations for submittal of a revised work plan, which will identify a new date for submittal of the IR. NMED hereby approves the Request.
