Dear Ms. Armijo and Mr. Bretzke:

The New Mexico Environment Department (NMED) has received and reviewed the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Request for Expedited Demolition Notification Approval for Structure TA-03-1966* dated April 14, 2017 and referenced by ECP-DO:17-152/LA-UR-17-22933.

As stated by the Permittees, investigations are not complete at several Solid Waste Management Units (SWMUs) and Areas of Concern (AOCs) located within 50 feet of the building (TA-03-1996) proposed for demolition. The Permittees state that they will ensure that the sampling locations and depths proposed in the approved work plans are not affected by these activities. In the case of adverse impacts to the SWMUs/AOCs where investigations are not complete, the Permittees must document all demolition activities that affected any SWMUs or AOCs in detail so that any impacts on work proposed at the SWMUs/AOCs can be identified and evaluated.

The Permittees must provide a copy of demolition reports, if prepared, to NMED within 30 days after the reports are complete in accordance with Permit Section 1.17.3.
