The Permittees understand that investigations may not be complete at Solid Waste Management Units/Areas of Concern (SWMUs/AOCs) located within 50 feet of the buildings proposed for demolition. The Permittees will ensure that the sampling locations and depths proposed in the approved work plans for the SWMUs/AOCs identified are not affected by the demolition activities. In the case of adverse impacts on the SWMUs/AOCs identified in this notification, demolition activities will be documented so that the impacts are identified and evaluated. demolition report is prepared for buildings that the Department has identified in writing, the Permittees will provide a copy of the demolition report to the NMED-HWB within 30 days after the report is completed in accordance with Section 1.17.3 of the Permit.
