Dear Messrs. Maggiore & Mairson:

Pursuant to NMSA 1978, Section 74-4-4.3.A of the New Mexico Hazardous Waste Act ("HWA"), NMSA 1978, §§ 74-4-1 to -14, the New Mexico Environment Department ("NMED") hereby requests that the United States Department of Energy and Los Alamos National Security, L.L.C. (collectively the "Permittees") provide NMED the below-listed information concerning activities associated with Los Alamos National Laboratory ("Facility") no later than July 30, 2018.

Section 74-4-4.3.A of the HWA provides that "[f]or the purposes of developing or assisting in the development of any rules, conducting any study, taking any corrective action or enforcing the provisions of the Hazardous Waste Act, upon request of the secretary or his authorized representative, any person who generates, stores, treats, transports, disposes of or otherwise handles or has handled hazardous wastes shall furnish information relating to such hazardous wastes...."

Upon review of the Permittees' response, dated April 5, 2018, to NMED's December 19, 2017 Request for Information, NMED is requesting the following additional information:

Your compliance with this information request is mandatory. Failure to respond fully within the time specified herein, or to adequately justify such failure to respond, may result in an enforcement action by NMED pursuant to Section 74-4-10 of the HWA.

LANL may claim confidentiality for any information required by this information request pursuant to the requirements of Sections 74-4-4.3.D and F of the HWA, and 20.4.1.100 NMAC (incorporating 40 CFR § 260.2).




