Dear Messrs. Goodrum and Mairson:

The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security (LANS), (collectively the Permittees's) *Notification of a Class 1 Permit Modification to the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit Waste Analysis Plan (Modification)* dated and received September 26, 2018; and referenced by EPC-DO-18-291/LA-UR-18-27810.

NMED has done a preliminary review of the Modification and has determined that the changes are not purely informational in nature, since the changes allow for the storage of different wastes not previously stored at the unit. NMED has determined that the Modification is more consistent with 40 CFR 270.42 Appendix I, item F.4.b (storage of different wastes in containers) and is therefore a Class 1 Permit Modification requiring prior approval. NMED discussed this with the

Permittees during a phone conference on October 3, 2018, and the Permittees agreed that this should be a Class 1 Permit Modification requiring prior approval.


NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. Upon receipt of the payment, NMED will initiate a technical review of the submittal in accordance with 20.4.2.201.B(3) NMAC.

Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If you disagree with the fee assessed, you may notify the NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Charlotte Duran, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
