The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B); collectively referred to as the Permittees, Class 1 Permit Modification Request Requiring Prior Approval for Treatment at TA-54-0375 for the Los Alamos Laboratory Hazardous Waste Permit, (Permit Modification) dated and received August 10, 2021, and referenced by N3B-2021-0197. NMED has reviewed the Permit Modification and determined that it is consistent with a Class 1 Permit Modification without prior approval in accordance with 40 CFR 270.42 Appendix I Classification of Permit Modification, Item F.1.c: to add treatment to TA-54-0375.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2), NMAC. The fee invoice is attached to this letter. If you disagree with the fee assessed, you may notify NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

The New Mexico Hazardous Waste Permit and Corrective Action Fee regulations, 20.4.2.201.F NMAC require assessment of fees. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Finance Manager at the NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
