The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE) (the Permittee) *Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, August 2021 (Quarter 16)* (Report) dated and received October 4, 2021 and referenced by LA-UR-21-29401/EPC-DO-21-295.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2), NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Finance Manager, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
