The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE) (the Permittee) *Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, November 2021 (Quarter 17)* (Report) dated and received January 3, 2022 and referenced by EPC-DO-21-404/LA-UR-21-32358.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2), NMAC. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Finance Manager, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
