On June 7, 2022, the New Mexico Environment Department (NMED) received the United States Department of Energy (DOE), Triad National Security (Triad), LLC, and Newport News Nuclear BWXT-Los Alamos, LLC (N3B) (collectively referred to as the Permittees) *Request for Class 2 Amendment to the Closure Plan Open Burning Treatment Unit Technical Area 16-399 Burn Tray* (Request) referenced by EPC-DO-22-145/LA-UR-22-24719.

NMED has reviewed the Request and the Response in accordance with 20.4.1.900 NMAC, incorporating 40 Code of Federal Regulations (CFR) 270.14. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
