The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE) (the Permittee) *Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, May 2022 (Quarter 19)* (Report) dated and received July 5, 2022 and referenced by EPC-DO-22-169/LA-UR-22-25789.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
