The United States Department of Energy (DOE), its field office the National Nuclear Security Administration, Los Alamos Field Office (NA-LA), and Triad National Security, LLC (Triad) provide this notification of demolition activity outside of regular quarterly reporting to the New Mexico Environment Department-Hazardous Waste Bureau (NMED-HWB). The Los Alamos National Laboratory Hazardous Waste Facility Permit (Permit), Section 1.17 requires a report of demolition activities at least 30 days prior to demolition of any building or structure.

Structure TA-64-0043 was not included in the *Demolition Notification for Fiscal Year 2023 and Quarter Ending December 31, 2022 and List of Buildings and Attachment of Hazardous Waste Descriptions* submitted to the NMED-HWB on August 29, 2022. Demolition of this structure is slated to start December 5, 2022, prior to submittal of the notification for the quarter ending March 30, 2023.
