Subject: Path Forward Regarding the Los Alamos National Laboratory General Part A and Part B Permit Application for Renewal of the Los Alamos National Laboratory Hazardous Waste Facility Permit, EPA ID #NM0890010515

Dear Mr. Cobrain:

The purpose of this letter is to provide an update to the New Mexico Environment Department-Hazardous Waste Bureau (NMED-HWB) regarding the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit (Permit) renewal application revisions and response to NMED-HWB's comments that LANL received in August 2022. The Permit authorizes the U.S. Department of Energy (DOE); Triad National Security, LLC (Triad); and Newport News Nuclear BWXT-Los Alamos, LLC (N3B), collectively the Permittees, to manage, store, and treat hazardous waste at LANL.

The Permittees submitted a Permit renewal application on June 29, 2020, which included three thermal treatment units, one for open burning and two for open detonation. All three units currently operate in interim status. Since then, the NMED-HWB and Permittees have engaged in comments and responses to move towards an administratively complete determination. The most recent formal correspondence is the Permittees' May 25, 2022, Response to Second Administratively Incomplete Determination General Part A and Part B of the Resource Conservation and Recovery Act Permit Renewal Application for Los Alamos National Laboratory EPA ID#NM0890010515, HWB-LANL-20-001.

On June 7, 2022, the U.S. Environmental Protection Agency (EPA) issued a memorandum regarding open burning and open detonation of waste explosives under the Resource Conservation and Recovery Act, which provides guidance for permitting these types of units. The Permittees planned and hosted the EPA, DOE personnel, personnel from other DOE facilities, and the NMED-HWB on November 30 and December 1, 2022, to address open burn/open detonation waste treatment at LANL. The site visit and the question-and-answer sessions provided insight into the intentions of the EPA memorandum and proposed rulemaking, as well as provided additional context for information that EPA and NMED-HWB would like to see in permit applications that contain a request to permit open burn and/or open detonation treatment units, such as the LANL Permit renewal application. The focus and time taken to coordinate the effort for the site visit and the development of responses to the EPA concerns has led to a delay in the revision of the Permit renewal application. The Permit tenewal application identified during the site visit is incorporated into the application and is clearly communicated.



The Permittees and the NMED-HWB met on July 27, 2022, to discuss a path forward on the Permit renewal and the potential for modifications during the renewal process. The parties reached a consensus for the Permittees to revise and resubmit the Permit renewal application to include responses to the NMED-HWB comments discussed during the meeting and to include a proposed permitted storage and treatment unit at Technical Area 60, Building 17 (TA-60-0017).

The NMED-HWB emailed supplemental informal comments, discussed during the July 2022 meeting, on August 8, 2022. Based on these comments and the information within the EPA memorandum, the Permittees began revision to the Permit renewal application. However, LANL delayed the submittal due to issues related to the application for the open burning/open detonation units and the potential impacts on waste activities.

In addition, over the last few months, the necessity for additional storage capacity flexibility became more urgent. Therefore, as discussed in a meeting with NMED-HWB on February 17, 2023, the Permittees submitted a Class 2 permit modification request to add a storage and treatment unit at TA-60-0017 prior to submittal of the revised Permit renewal application. The Request for Class 2 Permit Modification for the Addition of New Hazardous Waste Management Unit at Technical Area 60, Los Alamos National Laboratory Hazardous Waste Facility Permit, EPA ID #NM0890010515 was submitted to the NMED-HWB on March 13, 2023.

To accommodate the time and effort required for implementation of the Class 2 permit modification, the Permittees propose to submit a revised Part A and Part B Permit renewal application shortly after completion of the Class 2 permit modification action by the NMED-HWB. The revised Permit renewal application will include responses to the NMED-HWB's comments, enhanced information regarding open burning and open detonation treatment at LANL, and the results of the Class 2 permit modification request.
