The New Mexico Environment Department (NMED) has received the United States Department of Energy Environmental Management Los Alamos Field Office (DOE-EM) *Fiscal Year 2022 Nonconformance Report* (Report), dated December 22, 2022, and referenced by EPC-DO-22-327.

NMED notified DOE-EM of an error in Table 2 on January 19, 2023, and received *Replacement of Enclosure 2 in the Fiscal Year 2022 Nonconformance Report* (Replacement Table) (referenced by N3B-2023-0082) on March 14, 2023. NMED has reviewed the Report and the Replacement Table and is requesting information on the following items:

1. Copies of the additional information provided to Central Characterization Project (CCP) which was used to closeout characterization for containers in:

 - Table 2: 68273, 68278, 92536, and 92773.
2. For the containers listed above, also provide documentation of CCP's approval or acceptance of the additional information.

DOE-EM must provide additional information within 45-days of the receipt of this letter. In the future, please ensure that HWB LANL Permitting Group leader, Neelam Dhawan, is included on the cc list and that a redline copy is provided to NMED to facilitate the review of revised documents.
