The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE) (the Permittee) *Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, January 2023 (Quarter 22)* (Report) dated and received March 27, 2023, and referenced by EPC-DO-23-103/LA-UR-23-22949.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2), NMAC. The fee invoice is attached to this letter. If you disagree with the fee assessed, you may notify NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

The New Mexico Hazardous Waste Permit and Corrective Action Fee regulations, 20.4.2.201.F NMAC require assessment of fees. Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
