The New Mexico Environment Department (NMED) has received the United States Department of Energy's (DOE) (the Permittee) *Technical Area 63 Transuranic Waste Facility Soil Vapor Monitoring System Report, Calendar Year 2024, Quarter 4, November 2023* (Report) dated and received December 18, 2023, and referenced by EPC-DO-23-379/LA-UR-23-33613.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Vanessa Baros, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
