**SUBJECT: DEMOLITION NOTIFICATION FOR QUARTER ENDING MARCH 30, 2013
AND RESPONSE TO LETTER HWB-LANL-12-MISC DATED DECEMBER 7,
2012**

The United States Department of Energy (DOE) and Los Alamos National Security, LLC (LANS) (collectively the Permittees) have received your letter referenced above in response to our submittal of an *Expedited Demolition Notification for Structures at Technical Area 54* dated November 14, 2012. The expedited notification follows and adds to *Demolition Notification for Quarter Ending December 31, 2012 and Fiscal Year 2013*, that was submitted by the Permittees on September 13, 2012. Reporting for Fiscal Year (FY) 2014 as referenced in the letter received by the New Mexico Environment Department Hazardous Waste Bureau (NMED-HWB) has not been completed and the list of buildings in Enclosure 1 will be funded for demolition in FY 2013 not FY 2014. The buildings included within the expedited notification were submitted on November 14, 2013 because the next quarterly report deadline (December 31, 2012) would preclude the buildings from demolition within the quarter ending March 30, 2013.

Enclosure 1 (Demolition Reporting Quarter Ending March 30, 2013 List of Buildings and Attachment of Hazardous Materials Description) includes a description of the buildings or fixed structures scheduled for demolition, the associated hazards (if any) for buildings or fixed

structures and a listing of the hazardous materials that may be present in buildings as required by Permit Section 1.17.1. As requested by the NMED-HWB, a list of references for the solid waste management units (SWMUs) and Areas of Concern (AOCs) within 50 ft. of the footprint of the building proposed for demolition has been included as Enclosure 2.

The Permittees are aware that the NMED-HWB requested that copies of certain references be provided, however this information is not required under the conditions of Section 1.17 of the Permit and such a submittal would be provided voluntarily. The Permittees are requesting that NMED-HWB provide additional guidance regarding the information considered "relevant" to minimize the use of resources for potentially open-ended or on-going remediation projects and to guarantee that future demolition notice submittals are considered complete. The submittal of extensive supporting documentation for each project has the potential to result in burdensome and potentially irrelevant or duplicative information. The Permittees have provided supporting documentation (Enclosure 2) to meet the request for this transmittal.

The Permittees understand that investigations may not be complete at the Solid Waste Management Units (SWMUs) identified in the demolition notification. The Permittees will ensure that the sampling locations and depths proposed in the approved work plans will not be affected by these activities. Should inadvertent impacts occur on the SWMUs where the investigation is not complete, demolition activities will be documented so that the impact on the SWMUs can be identified and evaluated.

Pursuant to Section 1.17.3 of the Los Alamos Laboratory Hazardous Waste Permit, should a demolition report be prepared for any of the buildings included herein, the Permittees will provide a copy of such report to the NMED-HWB within 30 days after the final report is written.


