Dear Mrs. Roberts and Mr. Kieling:

Per conversations with Neelam Dhawan of your staff on February 11, 2016, the Permittees are notifying the New Mexico Environment Department (NMED) of an inadvertent delay in the notification of the receipt of a manifest discrepancy concurrence letter from Waste Control Specialists (WCS) as required by the Nitrate Salt-Bearing Waste Isolation Plan Revision 4 (Isolation Plan) Section 2(11). The notification was due to NMED no later than February 2, 2016, however, due to inadvertent delays, the document was hand delivered to NMED on February 11, 2016.

Similar to previous Isolation Plan non-compliance notifications, this information will be summarized in the next monthly technical report due February 17, 2016. Please contact me if additional information would be helpful. Thanks!
