Dear Mr. Feather:

Attached is a copy of the sampling data for the **first quarter of calendar year 2021.** The attached emissions data were obtained from the continuous air monitor installed on the main exhaust stack at the Beryllium Technology Facility (BTF) at Los Alamos National Laboratory (LANL). This submission of the quarterly emissions data, collected from this source, is required by permit condition 5.f of the New Mexico Environment Department (NMED) New Source Review (NSR) Air Quality Permit #634-M2 dated October 30, 1998. This quarterly report is transmitted within the allowed 60 days after the end of the calendar quarter, as specified in NSR permit and incorporated in Title V permit P100-R2M4.

Air Quality Permit #634-M2 condition #2 requires that the beryllium stack emissions from the BTF shall not exceed 0.35 grams in a 24-hour time period and shall not exceed 3.5 grams per year. For this reporting period, the current quarterly data and the total emissions for calendar year 2021 were obtained from the attached data sheet and summarized in the following table.
